Named after Rosie the Riveter, Camp Rosie is a 2-week summer day camp where girls can explore what the world has to offer them by learning trades and skills not often taught to young girls. In this girl-centered space, campers have an opportunity to express their potential while building friendships and making connections with female entrepreneurs and role models.

## ADMISSIONS AGREEMENT

As the parent or legal guardian of the below named camper, I understand, agree to and/or acknowledge the following:

**Cancellations or Withdrawal from Camp:** If your child is no longer able to participate in Camp Rosie, please inform the Camp Director as soon as possible so your child's spot can be offered to another child.

**What NOT to Bring to Camp Rosie:** Please do not send cell phones, electronic games, iPods, money or other personal possessions that could be at risk of being lost or stolen. YWCA Glendale will **not** be responsible for lost/stolen items. The following are prohibited: tobacco products of any kind, alcohol or drugs; lighters, matches, fireworks, explosives of any kind; guns, other weapons; silly string, permanent markers, spray paint; inappropriate reading materials; offensive or gang-related attire; personal sports equipment, super soakers, water guns, water balloons; animals or pets; or vehicles. Items brought to camp deemed inappropriate will be held by the Camp Director for parents to pick up.

**What to Wear to Camp Rosie:** Campers should wear comfortable clothing. Keep in mind that they will be fairly active throughout the day and they may get messy. No sandals, flip flops, clogs or bare feet. Campers need to come to camp wearing close-toed shoes such as sneakers.

**Sign-In & Out Procedure:** Campers must be signed-in and out by their Parent/Guardian or authorized person stated on the Emergency Contact & Sign-Out Authorization section. This process is required and no exceptions will be given. YWCA Glendale closes its doors at 6:00 pm sharp. **All campers must be picked up by 5:30 pm.** Repeated severe lateness may result in removal from the program. I understand that I am not to leave my camper at Camp Rosie unless a YWCA staff member or volunteer is there to receive and supervise my camper.

**Rights Reserved:** YWCA Glendale reserves the right to refuse service to anyone for any reason, and the right to change programs and services without notice.
